in the following fields

- 1) Scientific: medical biotechnology – oncology
- 2) Economic-social: medical biotechnology – oncology

Persons who fulfil all the following criteria

- have full civil rights on the territory of the Republic of Poland or – in the case of foreign experts – in their home country, or in their country of permanent legal residence
- have full legal capacity
- have no record of conviction by a final judgement for an intentional crime, or for an intentional fiscal offence, or, in particular, for a corruption-related offence or an offence perpetrated in relation to a public-procurement procedure, for an offence defined in the Act of 4 February 1994 on Copyright and Related Rights, or a bribery, trade-related, or other offence committed, to obtain financial gain
- have not been punished with a disciplinary penalty defined in Article 276 of the Act of 20 July 2018 - Law on higher education
- have the knowledge, skills, experience, or necessary authorisation in the required scope, i.e. have
 - for those applying for the position of Expert in the scientific area – medical biotechnology – oncology
 - at least a Doctoral Degree in any of the scientific disciplines in the fields of medicine and health science, or engineering-technical sciences, or exact and natural sciences, and documented, recognised scientific achievements in the fields of biotechnology or oncology, as well as achievements and experience in research-team management, including at the international level
 - scientific achievements involving participation in the substantive activities of research teams, including at the international level (e.g. foreign scientific centres, enterprises)

- which led to the development of technologies, inventions, or an active molecule, being the starting point for clinical trials
- publication records: monographs, publications, including those published in reputable indexed publications/foreign journals – related directly to the area of medical biotechnology – oncology, or international/prestigious prizes for scientific achievements
- for those applying for the position of Expert in the socio-economic field
 - higher-education and documented achievements and professional experience in the fields of innovation, commercialisation, and the implementation of new solutions in R&D, which led to clinical trials
 - experience in the management of high-risk funds (e.g. seed funds, VC, etc.)
- not employed by the Managing Entity, i.e. The Łukasiewicz Research Network – PORT – the Polish Centre for Technology Development;
- give their consent to the disclosure of their personal data on the List of WIB Experts, and their processing.

The scope of the tasks of Experts of the WIB Programme

1. Performing substantive evaluations of applications for funding Research Teams under the WIB Programme, in accordance with the Rules and regulations of the call for proposals for the selection of Research Teams carrying out scientific activities in the form of the Virtual Research Institute.
2. Participating in the Expert Panel attending the process of the substantive evaluation of Applications for funding Research Teams under the WIB Programme.
3. Participating in the appeal procedure, in particular in the form of substantive analyses concerning submitted appeals against the results of substantive evaluations.
4. Performing periodic Scientific Evaluations and the final evaluation of Research Teams based on the Criteria of Scientific Evaluation applied by the Managing Entity.
5. Preparing, at the request of Ł-PORT, additional opinions concerning Scientific Evaluations of Research Teams within the WIB Programme.
6. Preparing, at the request of Ł-PORT, opinions on the validity of expenditures of Research Teams operating within the WIB Programme, and the compliance of incurred expenditures with the Funding Agreement, and their relation to the fields of scientific activity set out in the Communication on Fields of Activities.
7. Issuing, at the request of Ł-PORT, other opinions to the extent necessary for the correct management of the WIB Programme.

A person applying for inclusion in the List of WIB Experts should submit

1. the filled in, signed with a handwritten signature, and scanned application for inclusion in the List of WIB Experts as per the template provided in Appendix No. 1, and a declaration, and consent for the processing of personal data

- scans of documents confirming compliance with the requirements concerning education and professional experience, and authorisations obtained in a given field.

The time limit for submitting applications

Applications for inclusion in the List of WIB Experts should be submitted in the period
from 01/12/2020 to 15/01/2021 until 4.00 p.m.

The time limit is considered to have been complied with if the documents are served before its expiry via electronic mail to the address wib@port.lukasiewicz.gov.pl

The procedure for submitting applications

Applications should be completed in electronic form (excluding signatures) and submitted with appendices, only by electronic means to the address wib@port.lukasiewicz.gov.pl.
